FITA rules and dress - NO CAMO, NO BLUE JEANS.

FITA Indoor 600 Round – 60 arrows in 20 ends of 3 arrows each at 18 meters. Scoring is 10, 9, 8... 0 at FITA multicolor targets – either single spot or 3 spot. Compound release scores inner ring (X ring) as 10 and the rest of the gold as 9. All other divisions score outer 10 ring as 10. Hits and Xs counted for tie breaking.

Maximum arrow diameter is 9.3mm. **23XX size arrows (except 2317) meet that requirement.**

18 meters equals 19 yards, 2 feet, and 0.7 inches.

Please note that you must register for either Senior OR Master. There is not an option to shoot both.
